- 1. Meeting was called to order at 7:33 pm (Atlantic), quorum having been met. The meeting was recorded and minutes were taken from the recorded meeting by Jane Sodero.
- 2. Presentation and Approval of Minutes of September 18, 2022 Board Meeting Peter MacDonald circulated these draft minutes.

Motion: To adopt the minutes from the September 18, 2022 Board Meeting. Moved by David McLaughlin; seconded by Joe Trauzzi. Motion passed.

3. Update from National Office, Membership – Lee Ann Stewart

Lee Ann Stewart reported that renewals are coming in quickly. Etransfers are working very well. She reported that there have been 97 new members added in 2022.

4. Financial, 2023 Budget, Grants – John Sharp

John Sharp circulated financial reports prior to the meeting. He noted The RPSC received a \$5000 bequest in November.

In addition, he went over the figures for the 2023 budget.

Motion: To adopt the proposed 2023 budget. Moved by Robert Pinet; seconded by Mike Walsh. Motion passed.

There was a discussion about the relationships among The RPSC, The RPSC Foundation and CAPE.

- 5. Sale of Let's Talk Exhibiting (English Edition) Mike Walsh
  - Mike Walsh reported that 159 copies of 300 have been sold.
- 6. Let's Talk Exhibiting (French Edition) Grégoire Teyssier

Sponsorships have been received to cover some of the costs of the layout and publication of 200 copies of the French translation. This will be a joint venture with FQP.

9. Royal 2023/London and other Royals – Sam Chiu

There was a lengthy discussion about proposals for Royal 2023 in London. ON. It was suggested that a group get together to prepare a list of wants and wishes for the show and then take it to the CANPEX organizers to see what can be accomplished. It was specified that the meeting between RPSC and CANPEX representatives should take place via Zoom or telephone and not by email.

10. Judging, regional judges, judges' honorarium at national shows, Stratford Club closing, requested support from Orapex 2023, Brigham Cup Team Competition rules - Joel Weiner

Joel Weiner commented that show organizers in both Canada and the US are worried about rising costs and that virtual aspects may take away from attendance.

Motion: To set the honorarium for judges at national shows will be \$450C (or \$450US for APS judges) for 2022-2024. Moved by Joel Weiner; seconded by Jane Sodero. Motion passed.

The proposal for the Ron Brigham Cup awarded for a virtual team competition was presented by Joel Weiner. He is hoping that the competition may be available at Royal 2023

The RPSC was asked for a donation to support Orapex cover the costs of frame set-up. Discussion about the request raised concerns about setting a precedent for providing funding to other National level shows and questions about the role of CAPE in funding shows and whether there should be a more comprehensive approach to how assistance is dispersed to shows.

Motion: Provide funding to Orapex to help with frame set-up costs. Moved by Joel Weiner; seconded by John Hall. Motion defeated.

A committee was formed to consider how The RPSC can address many of the concerns raised in the discussion.

Joel Weiner reported that a discussion had taken place about the requirement to be accredited as a regional judge before becoming an apprentice at the National level. Since many areas of Canada do not have regional show, this requirement has been eliminated.

11. Frames Storage - Ken Lemke; Sam Chiu

The frames will be stored in London for a monthly rental fee as of October 2023. There was some discussion of the need for frames. Sam Chiu asked if any board members had suggestions for storage to let him know.

12. Sale Circuit - Ken Lemke

13. FIP and International Shows – David McLaughlin

David McLaughlin outlined some upcoming international shows and reported of the Cape Town show where he was the commissioner and Sam Chiu was a judge.

14. Succession Planning – Lee Ann Stewart; Sam Chiu

Lee Ann reported that Mike Walsh and Sam Chiu's terms will end next year. In addition, John Hall, John Sharp, Robert Pinet and David McLaughlin are up for re-election. Robert Pinet and David McLaughlin indicated that they will not be re-offering so four people leaving the board.

Sam Chiu outlined some potential replacements. There was some discussion of possible francophone participation and it was noted that none of the potential replacements were women. The deadline for applications in December 12.

17. Publish Grand, Reserve and 1-F Grand winner exhibits – Joe Trauzzi

In a report circulated prior to the meeting, Joel Trauzzi proposed publishing the exhibits of Grand award winners at the Royal. No decision was made pending fuller information about costs and permissions.
