## CHRONICLE OF NEW ISSUES.

Our foreign and domestic correspondents are respectfully requested to send us specimens of, or information relative to, any new issues or discoveries that may chance to come under their notice. Such information will be duly appreciated, and proper credit given the donor. As it is our intention to make this department one of the best of its kind, we ask the aid of every individual correspondent to that end.

**ARGENTINE REPUBLIC.**—*The Philatelic Monthly and World* is authority for the statement that there are three distinct types of the 1 cent brown of 1884. The differences consist mainly in the lined ground-work.

**AUSTRIA.**—The new 20 kr., olive green (with original figures omitted in the lower corners) has been surcharged "2 PIASTER 2." The new 50 kr. violet has also been similarly surcharged "5 PIASTER 5."

**BAVARIA.**—The 5 Pf. green card now comes to hand with the date "91" and watermarked, waved vertical lines.

**BRAZIL.**—The 80 reis letter card is now red on rose.

**BRITISH HONDURAS.**—A contemporary states that the 1d. is now printed in green and surcharged "1 CENT" in black. It seems as if Seebeck has a hold on this republic as well as the other minor Central American States. We are about disgusted with the constant array of surcharges coming from this place.

**ECUADOR, the fallen.**—We are *very much pleased* (?) to inform our readers that in future their collection of this place can be greatly increased each year at a small cost. We are sure all will appreciate (?) the generous Seebeck (or successor) who has been so thoughtful in regard to their wants. The regular postage stamps have a full-face portrait of San Jose Flores. There are eight varieties of postage stamps, as follows: 1 centavo, orange; 2 centavos, blackish brown; 5 centavos, vermilion; 10 centavos, light green; 20 centavos, light chestnut-brown; 50 centavos, claret; 1 sucre, blue; 5 sucres, purple. Then come 7 varieties of official postage stamps, the same as the general issue, but surcharged "Franques Official" in red. Values are 1, 2, 5, 10, 20, and 50 centavos, and 1 sucre. There are also two varieties of newspaper wrappers, having large numeral figure of value in the centre: 1 centavo, light yellowish brown, size 151 by 304 millimeters; 2 centavos, chocolate brown, size 148 by 355 millimeters. There are also two varieties of post-cards and two varieties of envelopes; but we have neither time nor space to waste in the description of these issues.

**FRENCH CONGO.**—We are pleased to hear that the four unsightly wood-blocks chronicled by us in a recent number have turned out to be fraudulent.

**FIJI.**—*La Revue Philatelique* mentions a 4d. without surcharge of type, similar to the new 2½d.: 1891, 4d., lilac.

**ITALY.**—The 5 cent stamp now has the inscription in colored letters and the arms on horizontal lined ground.

**MARTINIQUE.**—The 20 cent unpaid letter stamp is in use at present for the prepayment of letters, being surcharged "Poste," and the new value "15 cent" in black. It would be a relief to stamp collectors if these worthless little colonies would quit this almost ceaseless array of surcharges. [Made to order on short notice!]

**MEXICO.**—The C. H. Mekeel Co., of St. Louis, have several sheets of different values of the current issue watermarked: CORREOS. E. U. M.

**MOZAMBIQUE.**—A royal decree changes the name of this province to "The Free State of East Africa;" we may therefore expect new stamps.

**MONTENEGRO.**—The 1 Nov. is now printed in rose and per. 12½.

**NOSSI-BE.**—Four new unpaid letter stamps have been issued by surcharging the ordinary stamps.—The value in figures is in the centre, "Nossi-Be" above, and "a Percevoir" below; value, 5 on 20c.; 10 on 15c.; 15 on 10c.; 25 on 5c. Next!

**ORANGE FREE STATE.**—*Le Timbre Poste* mentions a provisional postcard: 1891, ½d. on 1d., orange on white. This State has also, it seems, caught the surcharge fever.

**PERAK.**—Three new Tiger stamps are announced, similar to those of Pahang.

**SURINAM.**—*The Post Office* states that they have seen a new unpaid letter stamp from this place: 1891, 10 cent, gray, lilac and black.

**SIAM.**—A new 1 cent stamp was issued a short time ago: 1 cent, light green.

**SWEDEN.**—Two new values of the new current type, with head: 30 on brown and 50 on gray.

**UNITED STATES.**—We thank Mr. W. F. Leggett, of Brooklyn, who was the first to forward us unused copies of the new cards. We do not describe them, as we suppose all collectors will have seen them before this number is issued.

**DECLARATION OF INCORPORATION**  
— OF THE —  
**Philatelic Society of Canada.**

*Under Revised Statutes of Ontario, 1887, Chapter 172.*

The undersigned declare that they intend to be incorporated under the provisions of the said Act as an Incorporated Society.

NAME.

1. The name of the said Society shall be "The Philatelic Society of Canada," Incorporated.

PURPOSES.

5. The purpose of the said society shall be to further the advancement of Postage and Revenue stamp Collecting; to protect collectors of such stamps from frauds of all kinds in the exchange or sale of such stamps; to expose to collectors of such stamps dealers in counterfeit stamps; and to afford members an opportunity to exchange their stamps with one another and to perpetuate the postal history of the Dominion of Canada and other countries.

TRUSTEES AND OFFICERS.

3. There shall be eight trustees of the said Society, and the names of the first Trustees thereof are as follows:—J. R. Hooper, W. J. Beatty, G. T. Cary and Joseph Aube, of the City of Ottawa, in the County of Carleton; L. M. Stæbler and H. Dickson, of the City of London, in the County of Middlesex; W. McMahon of the City of Toronto, in the County of York, and J. S. Robertson, of the City of St. Thomas, in the County of Elgin.

4. The officers of the said Society shall consist of a President, Vice-President for Ontario, Secretary-Treasurer, Exchange Superintendent, Librarian and an Executive Council; three of such Officers shall be the Trustees of the Society and shall take seniority as above named. No member of the executive Council shall hold any other office.

Retiring Trustees shall be eligible for re-election.

5. The Trustees named in clause Three hereof shall hold the following offices in the said Society, until the close of the first annual meeting of the Society, or till their successors be appointed.

President—John R. Hooper; Vice President for Ontario—W. McMahon; Secretary Treasurer—L. M. Stæbler; Exchange Superintendent—J. S. Robertson; Librarian—H. Dickson; Executive Council—Joseph Aube, W. J. Beatty, G. T. Cary.

6. Trustees shall be elected annually at the Meeting of the Society from among the members thereof over the age of twenty-one years, and shall hold the respective offices they are elected to fill till the close of the next annual meeting or till their successors be appointed.

7. The duties and powers of the several officers shall be defined by the By-Laws of the Society.

8. The honorary officers of the Society shall be a Vice-President for each of the Provinces of Canada, (except Ontario) and for the United States, and such other officers as may be created by the Society; these shall be appointed by the Executive Council, their duties and powers shall be defined by the By-Laws.

9. The votes of the majority of the Executive Council shall in all cases decide a matter in which they have power to act.

10. In case of the resignation or the death of any Trustee or officer the Executive Council (or in case one or more of them should resign or die then the survivor or survivors and the President) shall forthwith appoint a successor to such trustee or officer to fill his

unexpired term or office and have all his rights and privileges.

11. An officer or trustee may be removed from his office by the Executive Council, for being negligent of his duties or unfaithful to the Society in manner provided in the By-Laws.

OFFICIAL ORGAN.

12. There shall be an official organ of the Society, in which proceedings of the Society, reports of officers and general business of the society shall be published. The Executive Council shall from time to time have the right, unless hereafter taken from them by By-Law of the Society, to name some newspaper or publication to be the official organ of the Society, and make all arrangements for remuneration thereof, and until they name one, THE CANADIAN PHILATELIST, published at London by L. M. Stæbler shall be the official organ of the Society.

MEMBERS.

13. Persons of either sex may become members of the said Society on the following proceedings being taken, or such proceedings as may be by By-Law hereafter substituted therefor.

(A) They shall apply in writing signed by themselves before a witness, and having their application signed by the members of the Society as references, in which application they shall agree to abide by and submit to the constitution and the By-Laws from time to time passed by the Society, and pay all dues and charges from time to time imposed by the By-Laws of the Society.

(B) Such application shall be sent to the Secretary-Treasurer, who will cause the name of the applicant to be published in the issue of the official organ published first after the receipt by him of such application.

(C) If no member sends in an objection to the said Secretary-Treasurer to said applicant becoming a member of the Society within thirty days from the issue of said official organ, the said applicant shall thereupon become a member of the Society. If any one shall object, the Secretary-Treasurer shall refer the matter to the Executive Council, who shall take such action in the premises as may be provided for in the By-Laws.

(D) They shall pay all fees or dues that may be fixed by By-Law.

(E) Members in good standing may resign in manner to be provided in By-Laws.

(F) The Executive Council shall have power to expel any member in manner to be provided in By-Laws.

14. As numerous persons have already applied to be members of The Philatelic Society of Canada, before the incorporation thereof was undertaken and have already furnished their names to L. M. Stæbler, the Secretary-Treasurer of the said Society, and published them in The Canadian Philatelist, the said names shall be published again (after the incorporation if completed) in the official organ, and numbered in the order they are published, and no objection being made as heretofore provided, they shall become members thereof. If objection is made, the Secretary-Treasurer shall proceed as in section 11, sub-section c.

MEMBERS AND POWERS OF TRUSTEES AND MEMBERS.

15. The general meeting of the Society shall be held at the City of St. Thomas, in the County of Elgin, on the second Tuesday in September of each year, and may be adjourned from time to time.

16. At the meeting of the Society, only the Trustee or the time being, or persons holding proxies in

them shall be entitled to vote or to be present without leave of the said Trustees.

17. At the annual meeting of the Society, the Trustees shall only have power to elect such officers, transact such business, and make such By-Laws as the members shall at their previous meeting have designated or approved of, in case there has been such a meeting held. If a mail vote shall be pending, the meeting shall adjourn from time to time till the result thereof is certified to the President, or any two other Trustees.

18. The members of the Society may meet annually before September 1st, at any time and place they may decide at the preceding meeting, except the meeting of such members that may be held before the second Tuesday in September, 1892, which shall be held at such time and place as the Executive Council may decide and give notice of in the official organ. If the meetings of members be held at the City of St. Thomas at any time, the same may be held at the same time and place as the annual meeting of the Society is held at.

19. At the meeting of the members, all members present in person or by proxy shall have power to vote provided they are in good standing under the By-Laws of the Society.

20. No official member shall at a meeting of members hold more than ten proxies; should any official member hold more than that number, then he shall forthwith assign the number he holds over ten to the President or to the next lower officer, who has not his full limit, and so on in the order of the seniority given in the fifth clause hereof, the seniority of the members of the Executive Council to be determined alphabetically, and if the trustees shall have as many as ten each then the member or members shall assign to the other members according to their seniority which shall be determined by the numbering of the members in the Society, the officers and members to be taken in rotation according to their seniority, and placing the proxies with the senior officer or member who has not the full number allowed to him. In voting proxies, any special instruction with the proxies shall be followed; but if assigned, then the holders for the time being shall, subject to such instruction, vote then without regard to any instructions from the person who has assigned them to him.

21. At the meeting of members they shall have the power to give directions to the Trustees how to act at the meeting of the Society in all matters, both to the election of officers, change and alterations of By-Laws and the general work of the Society, all which directions shall be binding on the Trustees except the same are varied as under section 20, sub-section D hereof. The officers shall at such meetings give a report of their work, and the general business of the Society shall be gone into and directions in regard thereto given to the Trustees, to regulate their action at the general meeting of the Society.

#### BY-LAWS.

22. The Society shall have power, subject to the provisions of this Constitution, to make By-Laws for the government of its members, regulating their rights and duties to each other and the Society, the duties and powers of officers, the creation of new offices, the mode of electing officers thereto, the limitations of membership and class of members to be admitted and generally to pass all By-Laws that may deem necessary for the management, direction, proper working and good government of the Society.

(B) The Executive Council shall forthwith, subject

to approval of the President, make such By-Laws for the Society, which shall continue in force till the annual meeting of the Society held after January 1st, 1892, at which the same may be approved or altered subject to the provisions of section 15.

(C) The By-Laws as then passed shall be published in the official organ, and shall in no case be changed or added to, unless notice of the proposed change or addition be given in the issue of the official organ, published thirty days before the date of the annual member's meeting, or unless the members present unanimously consent thereto.

(D) In the latter case the Society shall not pass the same, until the proposed change or addition has been published in the official organ and no protest against the Society enacting the same from any ten members has been received by the Secretary-Treasurer within fifteen days from the issue of the official organ. If such a protest is made, then the Secretary-Treasurer shall notify the President, who shall cause the Executive Council to call for a mail vote, to be taken on the proposed addition or alteration.

#### VOTING.

23. All votes shall be given, unless provided for in person, by proxy. A majority vote shall in all cases carry. The members at any members' meeting may decide that a mail vote be taken on any matter before them, except an election of officers.

24. A mail vote shall be taken as follows:—On the same being required either under clause 20, sub-section D of clause 21, the President (or on his refusal to do so, any three members) shall direct the Executive Council to prepare and call a mail vote. The Council shall thereupon forward to the members in good standing in the Society the ballots to be signed by them; fix the time same are to be returned, and to whom count said ballots, and certify the result of the poll to the President and Secretary-Treasurer, who shall act thereupon and notify the proper Trustees. Ballots not in the regular form shall be counted, if it can be ascertained from them how to voter intended to vote. Thirty days shall elapse from time of mailing ballots till close of vote.

#### NOMINATION AND ELECTION OF OFFICERS AND TRUSTEES.

25. Members shall nominate in writing to be sent to the Secretary-Treasurer, or such other officer as may be designated by the By-Laws, the members they propose to hold the various offices of the Society, and the Secretary-Treasurer, or such other officer so designated by the By-Laws shall in the last issue before the date fixed for holding the meeting of members, publish all such nominations in the official organ. All members in good standing shall have one vote for a member to hold each office.

The members may vote therefor as follows:—  
(A) Personally by ballot at the meeting of the members.

(B) By ballot sent in a sealed envelope to the Secretary-Treasurer, so the same shall reach him on or before the date of the members' meeting.

(C) By instructing their proxy to cast their ballot for the persons they are in favor of.

26. In case ballots are sent in as in section 25, sub-section B they shall have on the outside the member's number only, and shall not be counted unless the member is in good standing, which shall be ascertained before the envelope is opened. In case the vote is to be cast under sub-section C, there must be special instructions to that effect given with the names of those for whom that member wishes the ballot cast. No general proxy shall give power to the member

holding the same to cast a ballot for the grantor thereof. The member must be in good standing.

27. A committee of members shall be appointed to hold the poll at each meeting of members. The President or presiding officer, shall appoint two members thereof, and the members present the third.

It shall be their duty to examine all ballots, count same and report to the meeting.

28. The general meeting of the Society shall elect the persons Trustees who have received the largest number of votes according to said report, and designate them to the offices they were nominated to fill.

29. The Executive Council shall appoint to the appointive offices the persons who have received the largest number of votes, according to said report, and designate them to the offices they were nominated to fill.

## RULES OF THE EXCHANGE DEPARTMENT.

1.—Individual members may belong to either the Exchange or Sales Branch, but Branch Societies shall only participate in the Sales Branch. Members wishing to participate in the Exchange Branch must circulate sheets therein. Members may belong to both the Sales and Exchange Branches, but all transactions and accounts of such members shall, so far as each Branch is concerned, be kept separate and settled for according to the rules of each Branch and of the Exchange Department.—Members of Branch Societies may, at their option, participate in Branch circuits, or individual circuits, or both.

2.—All members of the Sales Branch who do not promptly remit will be dropped from all circuits and have their names listed by the Official Collector in the official organ. All members of the Exchange Department will be dropped from circuit who do not forward Exchange books to next on circuit in three days from receipt by them.

3.—Each member of the Exchange Branch shall at least twice a year, as soon as possible after June 30th and December 31st, select from sheet to be sent him by the Exchange Superintendent stamps to the full amount that may be due him by members for stamps taken by them belonging to him, unless the Exchange Manager sends cash instead.

4. Before a Branch Society shall be allowed to participate in the Exchange Department, its manager shall give a special agreement to the Society for payment for stamps taken, and the due return of all taken stamps and other obligation to be prepared by the Exchange Superintendent, and the said agreement shall be guaranteed by members of the branch over twenty-one years of age, and certified to be worth such sum as to the Exchange Superintendent seems proper.

5.—Whenever the rules may conflict with a member's agreement, the latter shall prevail in such particular, unless otherwise specified.

6.—Members removing a stamp from an exchange sheet must write their names plainly on the square from which the sheet is taken. If a square is blank, without stamp or name, it shall be the duty of the next member to notify the previous one, also the Exchange Superintendent. Failure to do so will make the last party responsible.

7.—All members must settle according to the terms of their contract, or they will have the accounts against them placed with the Official Collector for collection.

8.—All stamps must be circulated on sheets to be obtained from the Exchange Superintendent.

9.—Members must observe and strictly comply with the directions printed or written on the Exchange sheets or books, or attached thereto.

10.—Only sheets belonging to one member will be put in each book. Members are therefore requested to send in at least five sheets, if possible.

11.—All sheets must be sent by registered mail or express to next on circuit, in three days from receipt.

*To the Members of The Philatelic Society of Canada  
(Incorporated):*

I expected to be able to have reported in the last number of the official organ, but delay in getting the incorporation papers through delayed this. However, I am glad to say that on December 16th, 1891, the Judge of the County of Elgin approved of the Letters of Incorporation as they appear in this issue, and we are now an Incorporated Society, under the laws of Ontario, liable to all the disadvantages and entitled to all the benefits of a corporation, which latter are of a great advantage to us.

I am now in a position to handle the Exchange Department. Anyone can send in and receive stamps who signs an agreement such as is published in this number, procuring a guarantor to his due fulfilment thereof. The agreement will be furnished on application, and must be executed before a postmaster, notary or solicitor, who will furnish me a certificate as to the standing of the guarantor. This latter may be a member of the Society, but must be 21 years old and worth over \$50.00. It may be that some may object to this, but to such all I can say is this, that so long as I am the Exchange Manager I will insist on this from every one, and those who will always pay and put in a good class of stamps will only be too glad to furnish such an agreement, knowing that no one can obtain possession of what they put in without a similar agreement having been furnished.

I expect by the end of the year to have the best Exchange Department, both as regards quality of stamps and also quality of members, that there is on the Continent, for persons, when they find that they are secured in money matters, will not hesitate to put in the best class of stamps, so that it will be an advantage to every one. There will be no use asking to participate in the Exchange without signing one of these agreements.

So far as Branch Managers are concerned, I shall expect more security than \$50.00, as I shall send a larger assortment to them, and I would suggest that they make some arrangement for the the members of the Branch to guarantee their agreements.

In conclusion, I beg to state that I can now furnish Exchange sheets at 5 cents a-piece, and am now ready to put this department into harness at once. The rules will be found elsewhere, and will be rigidly enforced.

## EX. DEPARTMENT AGREEMENT.

I agree with The Philatelic Society of Canada (incorporated) as follows:

1. That I am a member thereof, and will comply with all the by-laws, rules and regulations thereof made or hereafter to be made, and pay all indebtedness on my part to said Society payable by members for dues, balances on exchange accounts, assessments, and otherwise.

2. That I will, within three days from the date of the receipt by me or my agent, as hereafter defined, from the post or express office (which receipt may be proved by affidavit of the postmaster or express agent acting at the time proof is required, whether in a lawsuit or otherwise), forward to the next on circuit, by registered mail or express, all exchange books sent to

me by the Exchange Manager, or the members on the circuit by his direction or otherwise; and that I will also send at said time to the Exchange Superintendent a statement of the date of receipt and forwarding of all exchange books by me, and the amounts taken from each book; and in default of my doing both or either of said things, I agree that I will forfeit and pay on demand of the Exchange Superintendent a fine of ten cents per day, which said Society may deduct out of any moneys coming to me or retain stamps to the amount.

3. I hereby become a member of the Exchange Branch of the Exchange Department of said Society, and I agree to take payment for all stamps taken from my sheets sent in by me to said Society by taking stamps from sheets sent in by other members of said branch, and which may be sent to me to select from, and not demand payment in money, the Society to be at liberty, should they prefer, to pay me any balance in cash. I request Exchange Branch books to be sent me.

4. I hereby become a member of the Sales Branch of the Exchange Department of the said Society, and I agree that I will, within the three days from the receipt of any exchange books received by me limited by clause 2 hereof for sending the statement to the Exchange Superintendent, remit to him payment in full in cash for all stamps at the value fixed to them in the said exchange sheets taken by me. I request Sales Branch books to be sent to me.

5. That I am manager of the Branch of this Society, and that as such I request books of the Sales Branch only to be sent to me. I agree personally to pay the Society for all stamps that may be taken out of any books that may be sent to me as such manager while on circuit, or otherwise, from the time I or my agent may receive same from the post or express office till I mail them by registered mail or express them to the next on circuit, and the Society are to look to me personally, and not to any member of the Branch Society of which I may be a member, for the stamps taken out of said book while in my possession; and for the purpose of this agreement, all books and stamps shall be taken to be in my possession from the time of my receiving same to the time I forward them by registered mail or express to the next on circuit. All the other clauses of this contract which regulate the liabilities of members to whom exchange books, etc., are sent in their personal capacity, shall apply to me as manager of the Branch, except that in place of three days to forward the books to the next on circuit and remit the Exchange Manager, I shall have a day for each person that I may notify the Exchange Manager as a member of the Branch—in no case, however, to exceed fifteen days; and in default of my doing both or either of the said things, I will forfeit and pay on demand of the Exchange Superintendent to said Society a fine of ten cents per day for each day over that time that I either keep said books or fail to remit for stamps taken, or both. I declare there are members of the Branch, which shall be considered the full number till I notify the Exchange Superintendent to the contra.

6. I hereby constitute, so far as the said Society is concerned, the person to whom from to time the postmaster in charge of the post-office at my address, as given under my signature hereto, may deliver any exchange books sent by registered mail to me, or to whom the express agent may deliver any exchange books sent by express for me, as my agent, to receive the same with full power to bind me by signing a receipt on my behalf and my receiving same.

7. That all stamps sent to the Society by me for either the Exchange or Sales Branch shall be absolutely under the control of the Society; and for the purpose of circulating them among members and collecting the prices of the stamps taken, I set over and assign to said Society all stamps that may be sent in by me to the Exchange Department, and I hereby constitute them my attorneys to sue for and recover in my or their name the value of all stamps taken by any member from said books. The said Society is not to be liable for the return or value of any stamps that have been sent in by me to the Exchange Department for circulation among the members thereof that may be lost by members, unless the said stamps are lost through wilful default of the Society or some officer thereof, or the money value of the stamps has been actually received by the said Society, which is to be considered, so far as I am concerned, as a gratuitous bailee; nor will I hold any member responsible for stamps lost in transit, if forwarded by registered mail or express.

8. That I will pay said Society, or the member owning the stamps, the full value of all and any stamps that may become lost while on circuit after they have reached me, and while in my possession, and till they actually reach the next member on circuit. In case I do not forward them within three days from receipt by registered mail or express, my liability to end on my obtaining a registered receipt from the post-office master or receipt from the express company for same in such time.

9. That I will abide by, conform and submit to and carry out the rules for the government of the Exchange Department of the said Society that may be made by the Exchange Superintendent and published in the official organ. This to apply not only to the rules in force at the time of my signing this contract, but which may hereafter be made the time for my liability thereunder to arise in all cases from the date of the publication thereof in the official organ of the Society for the time being.

10. In case I do not promptly pay any indebtedness I owe the Society or any member (after he has placed it in the hands of the official collector) after the first notice to pay is mailed by the official collector to my address as in the hands of the secretary-treasurer, I authorize the Society and the official collector to have my name printed in the official organ in bold type, prominent and distinct, together with the amount I owe, and any statement of the facts of the case, whether said account is correct or not, provided the Society or collector believes it, and provided I do not reply to the letters of the collector; but if I do, then my explanation is to be shortly given, together with the amount of my debt, etc. There is to be no liability for such publication on the part of the Society, its officers, or the member to whom I am a debtor.
